TRUSTEE’S MOTION TO SELL FREE AND CLEAR OF LIENS AND ENCUMBRANCES, NOTICE OF SALE, MOTION TO APPROVE COMPROMISE AND SETTLEMENT, AND NOTICE OF HEARING

Comes now Jerrold D. Farinash, Chapter 7 Trustee, by and through Kennedy, Koontz & Farinash pursuant to 11 U.S.C. §363 and Rule 9019, Federal Rules of Bankruptcy Procedure and moves this honorable Court for an Order allowing him to sell any and all interest the Estate possesses, *if any*, in

A. That certain Dealer Sales and Service Agreement (or similar such agreement) by and between the Debtor, Prebul Jeep, Inc. (Case No. 09-10838) and

Chrysler LLC, allowing the sale of Chrysler, Jeep and Dodge vehicles, and that certain Dealer Sales and Service Agreement (or similar such agreement) between this Debtor and Kia Motors America, Inc., allowing the sale of Kia vehicles in the Chattanooga, Tennessee market area, and the Debtor's "Blue Sky" rights related to the said dealerships;

B. That certain Dealer Sales and Service Agreement (or similar such agreement) by and between the Debtor, Prebul Motors of Dalton, LLC (Case No. 09-10840) and General Motors Corporation allowing the sale of Pontiac, Cadillac, GMC Trucks and Buick vehicles, and the Debtor's "Blue Sky" related to the said dealerships;

C. That certain Dealer Sales and Service Agreement (or similar such agreement) by and between the Debtor Prebul Automotive of Dalton, LLC (Case No. 09-10841) and Mazda Motors of America allowing the sale of Mazda vehicles, and the Debtor's "Blue Sky" rights related to the said dealership;

D. That certain Dealer Sales and Service Agreement (or similar such agreement) by and between the Debtor Prebul Imports of Dalton, LLC (Case No. 09-10842) and Kia Motors America, Inc., allowing the sale of Kia vehicles in the Dalton, Georgia market area, and the Debtor's "Blue Sky" right related to the said dealership;

E. That certain Dealer Sales and Service Agreement (or similar such agreement) by and between the Debtor Prebul Motorcars, LLC (Case No. 09-10844) and Volvo of America allowing the sale of Volvo vehicles, and the Debtor's "Blue Sky" rights related to the said dealership; and,

F. That certain Dealer Sales and Service Agreement (or similar such agreement) by and between the Debtor, Prebul Infiniti of Chattanooga, LLC (Case No. 09-10845) and Infinity Division of Nissan North America, Inc., allowing the sale of Infinity vehicles, and the Debtor's "Blue Sky" rights related to the said dealership;

free and clear of the liens, claims and encumbrances. The Trustee also seeks to approve the Compromise and Settlement entered into between the Trustee and Chrysler Financial Services America, LLC, Regions Bank and FSG Bank, all as is outlined herein.

CASES AND LIENS

1. These cases have been administratively consolidated pursuant to an Order entered on March 5, 2009.

2. The case of Prebul Jeep, Inc. was commenced on February 11, 2009, and was assigned case number 09-10838 in this Court. At the time that case was commenced the Debtor was a party to a dealer sales and service agreement (or similar such agreement) with Chrysler, LLC and Kia Motors America, Inc. At the time of the filing, the Debtor was, and continues to be the holder of certain rights under that dealer agreement as set forth herein. Additionally the Estate possesses certain rights under T.C.A. § 55-17-101 et. seq. Chrysler Financial Services America, LLC, and FSG Bank assert liens in the property rights of this Debtor.

3. The case of Prebul Motors of Dalton, LLC. was commenced on February 11, 2009, and was assigned case number 09-10840 in this Court. At the time that case was commenced the Debtor was a party to a dealer sales and service agreement (or similar such agreement) with General Motors Corporation. At the time of the filing, the Debtor was, and may continue, to be the holder of certain rights under that dealer agreement as set forth herein. Additionally the Estate possesses certain rights under Georgia Law. Regions Bank and FSG Bank assert liens in the property rights of this Debtor.

4. The case of Prebul Automotive of Dalton, LLC. was commenced on February 11, 2009, and was assigned case number 09-10841 in this Court. At the time that case was commenced the Debtor was a party to a dealer sales and service agreement (or similar such agreement) with Mazda Motors of America. At the time of the filing, the Debtor was, and may continue, to be the holder of certain rights under that dealer agreement as set forth herein. Additionally the Estate possesses certain rights under Georgia Law. Regions Bank asserts a lien in the property rights of this Debtor.

5. The case of Prebul Imports of Dalton, LLC. was commenced on February 11, 2009, and was assigned case number 09-10842 in this Court. At the time that case was commenced the Debtor was a party to a dealer sales and service agreement (or similar such agreement) with Kia Motors America, Inc. At the time of the filing, the Debtor was, and may continue, to be the holder of certain rights under that dealer agreement as set forth herein. Additionally the Estate possesses certain rights under Georgia Law. Regions Bank asserts a lien in the property rights of this Debtor.

6. The case of Prebul Motorcars, LLC. was commenced on February 11, 2009, and was assigned case number 09-10844 in this Court. At the time that case was commenced the Debtor was a party to a dealer sales and service agreement (or similar such agreement) with Volvo of America. At the time of the filing, the Debtor was, and may continue, to be the holder of certain rights under that dealer agreement as set forth herein. Additionally the Estate possesses certain rights under T.C.A. § 55-17-101 et. seq. Regions Bank asserts a lien in the property rights of this Debtor.

7. The case of Prebul Infiniti of Chattanooga, LLC. was commenced on February 11, 2009, and was assigned case number 09-10844 in this Court. At the time that case was commenced the Debtor was a party to a dealer sales and service agreement (or similar such agreement) with Infinity Division of Nissan North America, Inc. At the time of the filing, the Debtor was, and may continue, to be the holder of certain rights under that dealer agreement as set forth herein. Additionally the Estate possesses certain rights under T.C.A. § 55-17-101 et. seq. Regions Bank and FSG Bank assert liens in the property rights of this Debtor.

PROPOSED SALES AND BUYERS

8. The Trustee proposes to sell the rights of each the Debtors in each of their respective dealer sales and service agreements (or similar agreements), their “Blue Sky” rights, as well as their statutory rights under Tennessee or Georgia law as follows:

A. Prebul Jeep, Inc. Case No. 09-10838, for the sale of Chrysler, Jeep, and Dodge vehicles to the highest and best buyer as determined by the Court at the hearing on this Motion;

B. Prebul Jeep, Inc. Case No. 09-10838, for the sale Kia vehicles to John P. Konvalinka, Agent for a currently undisclosed Principal, 633 Chestnut Street, Suite 900, Chattanooga, Tennessee 37402 or his assignee for \$300,000.00, or to such other, higher and better buyer as may come before the Court before the approval of this sale;

C. Prebul Imports of Dalton, LLC, Case No. 09-10842, for the sale of Kia vehicles in Dalton, Georgia; Prebul Motors of Dalton Case No. 09-10840, for the sale of Pontiac Cadillac, GMC Truck, Buick vehicles in Dalton, Georgia; and, Prebul Automotive of Dalton, LLC, Case No. 09-10841, for the sale of Mazda vehicles in Dalton, Georgia Edd Kirby’s Adventure Chevrolet, Chrysler and Jeep, 1501 West Walnut Avenue, Dalton, Georgia 30720 for \$85,000.00, or to such other, higher and better buyer as may come before the Court before the approval of this sale;

D. Prebul Motorcars, LLC, Case No. 09-10844 for the sale of Volvo vehicles to Marshall Mize Ford, Highway 153 at Hixson Pike, Chattanooga, Tennessee 37343 for \$125,000.00, or to such other, higher and better buyer as may come before the Court before the approval of this sale;

E. Prebul Infiniti of Chattanooga, Case No. 09-10845 for the sale of Infiniti vehicles to LMKS, LLC, 2121 Chapman Road, Chattanooga, Tennessee 37421 for \$101,000.00, or to such other, higher and better buyer as may come before the Court before the approval of this sale.

9. The 11 U.S.C. § 363 basis for the sale of these rights free and clear of the liens of Chrysler Financial Services America, LLC, Regions Bank and FSG Bank is that each lien holder will consent to the sale and the liens are in bona fide dispute.

10. Each sale as outlined above is contingent upon approval of the individual Buyer as a sales and service agreement holder by each respective new car Manufacturer. To the extent these offers contemplate the relocation of any one or more franchises from their current location to a currently existing new car franchise location, such sale is contingent upon the existing Manufacturer approving such move.

COMPROMISE AND SETTLEMENT

11. As stated above, Chrysler Financial Services America, LLC, Regions Bank and FSG Bank, each assert security interest in some or all of the assets of the aforesaid estates. One of the assets to be sold in each case is the Debtor's "Blue Sky" rights. The Trustee asserts that neither Chrysler Financial Services America, LLC, Regions Bank nor FSG Bank has a security interest in the "Blue Sky" rights of the Debtor.

12. A dispute exists between the Trustee and Chrysler Financial Services America, LLC, Regions Bank and FSG Bank as to whether or not any of those entities has a security interest in the Debtor's "Blue Sky" rights, or the Debtor's rights under Tennessee and Georgia State law.

13. In order to resolve this dispute, the parties have agreed, subject to Court approval, to resolve this dispute as follows:

A. The Trustee shall continue to operate the various dealerships until such time as those operations taken over by a successful buyer either after approval by the manufacture or pursuant to a management agreement to be entered into after this sale is approved; and

B. After all sales contemplated by this Motion are consummated, the proceeds from the sale of the “Blue Sky” Rights plus any monies collected by the Trustee as the result of the operations of the Debtors, less the cost to operate the Debtors as set forth in the Court’s Order approving the Use of Cash Collateral in this matter shall be divided 50% to the Estates and 50% to either Chrysler Financial Services America, LLC, Regions Bank or FSG Bank as their respective rights may appear or be agreed upon.

14. The Trustee avers the settlement as outlined above is in the best interest of the Estate as it allows the Trustee to continue operations of the Debtor entities which will allow for the greatest likelihood for the maximization of the value of the assets of each Debtor.

NOTICE OF SALE

15. Each of the sales as outlined above shall be consummated on or after 10 days for the entry of a final, non-appealable order approving such individual sale.

WHEREFORE, JERROLD D. FARINASH, TRUSTEE PRAYS AS FOLLOWS:

A. At the hearing on this Motion the Court approve the sales free and clear of liens as is outlined herein;

B. At the hearing on this Motion the Court approve the Compromise and Settlement as is outlined herein; and,

C. That the Trustee have such other and further relief as may be just.
