## NARRATIVE

ON 07/09/2010 AT ABOUT 0204 HOURS I RESPONDED TO 1820 CUMBERLAND AVENUE, BAR KNOXVILLE, IN REFERENCE TO AN OFFICER NEEDING ASSISTANCE. UPON MY ARRIVAL THE BAR STAFF DIRECTED ME TO THE SIDE OF THE BUILDING TO A GROUP OF MALES THAT HAD SUPPOSEDLY ASSAULTED AN OFF DUTY KNOXVILLE POLICE DEPARTMENT OFFICER. UPON IDENTIFYING MYSELF AS A POLICE OFFICER AND ORDERING THE GROUP TO STOP, I MADE CONTACT WITH AN INDIVIDUAL, LATER IDENTIFIED AS A MR. DARREN MYLES A U.T.K. STUDENT. MR. MYLES FLED FROM ME ON FOOT SOUTHBOUND TOWARDS LAKE AVENUE. AFTER A FOOT CHASE, DURING WHICH MYLES STRUCK ME WITH HIS ELBOW UNDER MY LEFT EYE. HE WAS TAKEN INTO CUSTODY AND CHARGED WITH ASSAULT, RESISTING A STOP AND FLEEING/EVADING ARREST.

ON 07/09/2010 AT ABOUT 0230 HOURS, I WAS ASSISTING CPL. GREENLEE WITH A SEARCH OF THE AREA NEAR LAKE AVENUE AND 18TH STREET FOR AN INDIVIDUAL THAT HAD ASSAULTED HIM AND FLED ON FOOT FROM CPL. GREENLEE FROM 1820 CUMBERLAND AVENUE. WHILE SEARCHING THE AREA MYSELF AND SERGEANT J. KECK OF THE KNOXVILLE POLICE DEPARTMENT WALKED TOWARDS A WHITE BMW THAT WAS PARKED BEHIND THE OLD DAYS INN BUILDING. AT THAT TIME WE OBSERVED A BLACK MALE LATER IDENTIFIED AS MR. DARRIN MYLES A U.T.K. STUDENT HIDING UNDER THE WHITE BMW. I INSTRUCTED MR. MYLES TO COME OUT FROM UNDER THE VEHICLE AND AT THAT TIME MR. MYLES THEN FLED ON FOOT EASTBOUND ON LAKE AVENUE. I THEN ADVISED DISPATCH THAT I WAS IN A FOOT PURSUIT WITH THE SUSPECT. MR. MYLES THEN RAN BEHIND THE HOWARD BAKER BUILDING AND PROCEEDED TO RUN THRU THE BREEZEWAY OF GREVE HALL THEN NORTH BY HENSON HALL. MR. MYLES WAS LOCATED HIDING IN THE BUSHES NEXT TO HENSON HALL AND WAS TAKEN INTO CUSTODY WITHOUT FURTHER INCIDENT AND WAS DETAINED IN THE REAR OF VEHICLE 67.

ON 07/09/2010 AT ABOUT 0204 HOURS I RESPONDED TO BAR KNOXVILLE LOCATED AT 1820 CUMBERLAND AVENUE IN REFERENCE TO AN OFFICER NEEDING ASSISTANCE. UPON MY ARRIVAL THE BAR STAFF DIRECTED ME TO THE SIDE OF THE BUILDING TO A GROUP OF BLACK MALES THAT HAD SUPPOSEDLY ASSAULTED AN OFF DUTY KNOXVILLE POLICE DEPARTMENT OFFICER. THE INDIVIDUALS WERE LATER IDENTIFIED AS A MR. DENARIUS MOORE, DA'RICK J ROGERS, JOHN BROWN, MATTHEW MILTON, JERRAN TALLEY AND A MR. DARREN MYLES. ALL OF THESE INDIVIDUALS EXCEPT FOR MR. TALLEY ARE U.T.K. STUDENTS. UPON IDENTIFYING MYSELF AS A POLICE OFFICER AND ORDERING THE GROUP TO STOP MR. MYLES FLED FROM ME ON FOOT SOUTHBOUND TOWARDS LAKE AVENUE. I CALLED TO DISPATCH AND ADVISED THAT I WAS IN A FOOT PURSUIT. I OBSERVED MR. MYLES CONTINUE DOWN LAKE AVENUE WHERE HE ATTEMPTED TO HIDE FROM ME. WHEN I MADE CONTACT WITH MR. MYLES I ORDERED HIM TO STOP AND I ATTEMPTED TO PLACE A RESTRAINT HOLD ON HIM TO TAKE HIM TO A PRONE HANDCUFFING POSITION. MR. MYLES CONTINUED TO RESIST ME SLIPPING OUT OF MY GRASP AND HE STRUCK ME WITH HIS ELBOW JUST UNDER MY LEFT EYE AND PROCEEDED TO FLEE FROM ME ON FOOT TO THE PARKING GARAGE BESIDES THE MCDONALDS RESTAURANT WHERE I LOST CONTACT WITH HIM. AT ABOUT 0230 HOURS OFFICER C. MCCANN ALONG WITH KNOXVILLE POLICE DEPARTMENT SGT J. KECK MADE CONTACT WITH MR. MYLES NEAR THE DAYS INN BUILDING JUST OFF LAKE AVENUE. MR. MYLES ATTEMPTED TO FLEE FROM OFFICER MCCANN TOWARDS THE HOWARD BAKER BUILDING WHERE HE WAS FINALLY DETAINED AND PLACED IN THE REAR OF VEHICLE 67. AT ABOUT 0247 MYSELF AND CPL. ZAREMSKI TRANSPORTED MR. MYLES TO THE KNOXVILLE POLICE DEPARTMENT 3RD FLOOR FOR QUESTIONING. AFTER BEING QUESTIONED BY THE KNOXVILLE POLICE DEPARTMENT, MR. MYLES WAS PLACED IN CUSTODY AT 0436 HOURS. MR. MYLES WAS SEARCHED INCIDENT TO ARREST AND PLACED IN THE REAR OF CAR 62, SEAT BELTED, AND TRANSPORTED TO KNOX COUNTY INTAKE FOR PROCESSING. A COPY OF THE ARREST REPORT WILL BE ATTACHED TO THE MAIN REPORT AND THIS SUPPLEMENT.

KPD HAS CHARGED DA'RICK ROGERS WITH RESISTING ARREST AND FLEEING. CHARGES ARE PENDING ON MATTHEW MILTON FOR ASSAULT.
