On 04/10/2009 at 23:30 hours, Officers David Cowan EMP # 61210 / EMP # responded to Assault, Simple at 1826 Carter St. and Jasmine Johnson advised that on 3/20/09, she was a victim of hazing. Ms. Johnson said that she was pledging to the sorority Delta Sigma Theta, and had completed several phases. She said she was told to be at The Pavilion next to Finely Stadium on 3/20/09 for another process. While at this location, she advised that she was approached by Seirra Smith, a sorority member and Parleментарian. She said Seirra, during this process, approached her and began punching her in the side of her head. She said Seirra did this several times while two other unknown girls from the sorority were behind her. She said one of the unknown girls poured ice cold water on her head, while the other had a water gun and began shooting vinegar on her. She said the girl also shot this vinegar into her eyes and face, but the vinegar was burning her eyes, and she could not identify that girl.

Ms. Johnson was taken to Parkridge East on 3/24/09 for injuries received in that incident, and was diagnosed with a concussion.

There are two other related incidents to this one. The second incident occurred at 1020 N. Moore Rd. complaint number 09-032223. The third incident occurred at 651 E. 5th St. complaint number 09-032224.

Car 312, Investigator Holloway was notified of the incidents.

On 04/10/2009 at 23:30 hours, Officers David Cowan EMP # 61210 / EMP # responded to Assault, Simple at 1020 N. Moore Rd. and Jasmine Johnson advised, as a continuation from complaint number 09-032195, she was told to be at Brainerd High School in the track area, for another process of initiation into the sorority, Delta Sigma Theta. As in the previous incident, she said Seirra Smith approached her. At the same time, Jada Davis and Rikkee Lee approached her and began to pour chocolate syrup and milk over her head. After being covered in the syrup and milk, she said Seirra broke eggs over her hair and head. Then Seirra placed an egg on her chest, and then punched her in the chest, breaking the egg. Ms. Johnson said Seirra continued, and placed an egg on her stomach, and punched her in the stomach. Ms. Johnson said as she rolled over, holding her stomach from being punched, Seirra then kicked her in the stomach. Shortly thereafter, Ms. Johnson said she noticed that she was bleeding from her vagina. Afterwards, she was also paddled with a wooden paddle, bearing the Delta triangle, on her legs and knuckles.

Ms. Johnson attend a ceremony on 3/24/09, and was "pinned" as acceptance into the sorority. She said that she was still bleeding and was suffering from extreme headaches and stomach pains. She said it was then that she told her mother, Karen Drake, what all had happened, and Mrs. Drake took her daughter to Parkridge East Hospital. Ms. Johnson said that she suffered from a concussion, bruising, and contusions to the stomach.

Ms. Drake reported the incidents to the organization, who told her they would handle the incident internally. Related complaint numbers, 09-032195 and 09-032224. Car 312, Investigator Holloway was notified of the incident.

On 04/10/2009 at 23:30 hours, Officers David Cowan EMP # 61210 / EMP # responded to Assault, Simple at 651 E. 5th St. and Jasmine Johnson advised, as a continuation to complaint numbers 09-03223 and 09-03224, she was in the car with her mother, Karen Drake, waiting to go to a meeting with the people from the organization of Delta Sigma Theta. She said they were in her mothers car, parked on 5th St. in front of the UTC Bookstore. She said she notice Chelsey Lay in the vehicle behind them. Chelsey is the 1st Vice President of Delta Sigma Theta. Ms. Johnson said she noticed her on the phone, and shortly thereafter, Rikkee Lee (Financial Secretary), and Tarekia Dentley showed up and got into the vehicle with Chelsey. They were in a black Nissan bearing TN tag 406-LKF which is registered to Delores Lay in Memphis, TN. Mrs. Drake said she pulled forward several times and urged the girls to go on. Ms. Johnson said it was then time for the meeting, and got out of the car to walk up the sidewalk to the building. She said Chelsey then pulled up next to her mother, rolled her window down and shouted, "Bitch, you better watch your back". She said they then pulled off, which is when Mrs. Drake was able to obtain their tag number.

After speaking with an attorney, they reported the incidents to UTC Police. They made a report and also advised them to make a report with Chattanooga Police.

Car 312, Investigator Holloway, was notified of the incidents.
