**AFFIDAVIT OF COMPLAINT** In the General Sessions Court of Hamilton, State of Tennessee vs. WALKER, JOHNTHONY

The undersigned affiant, after being duly sworn according to the law WALKER JOHNTHONY whose name is otherwise unknown to the affiant, committed the offense of VEHICULAR HOMICIDE VEHICULAR in the above county at (Location) 3410 AMNICOLA HWY on or about 11/21/201 Further, affiant makes oath that the essential facts constituting said offense, the sources of affiant's information, and the reasons why his/her information is believable concerning said facts are as follows:

THE DEFENDANT JOHNTHONY WALKER WAS DRIVING A LARGE HAMILTON COUNTY SCHOOL BUS TRANSPORTING CHILDREN HOME FROM WOODMORE ELEMENTARY. THE DEFENDANT WAS TRAVELING AT A HIGH SPEED ON TALLEY ROAD, WHICH IS A NARROW WINDING ROAD. BASED ON WITNESS STATEMENTS AND PHYSICAL EVIDENCE THE DEFENDANT WAS DRIVING THE SCHOOL BUS AT A HIGH RATE OF SPEED, WELL ABOVE THE POSTED SPEED LIMIT OF 30 MPH. MR. WALKER LOST CONTROL OF THE BUS AND SWERVED OFF OF THE ROADWAY TO THE RIGHT, STRIKING AN ELEVATED DRIVEWAY AND MAILBOX, SWERVED TO THE LEFT AND BEGAN TO OVERTURN, STRIKING A TELEPHONE POLE AND A TREE. THE CRASH CAUSED FATAL INJURIES TO FIVE (5) STUDENTS, MULTIPLE CRITICAL AND NON CRITICAL INJURIES TO MORE THAN 20 STUDENTS. AT TOTAL OF 25 STUDENTS WERE ON BOARD ACCORDING TO HAMILTON COUNTY SCHOOL OFFICIALS. BECAUSE OF THE RECKLESS NATURE OF MR WALKER'S DRIVING, COMBINED WITH HIS VERY HIGH SPEED AND WEAVING WITHIN HIS LANE, MR. WALKER WAS CHARGED WITH FIVE COUNTS OF VEHICULAR HOMICIDE BY RECKLESSNESS, RECKLESS ENDANGERMENT, AND RECKLESS DRIVING.
